### CUMULATIVE FUND PERFORMANCE (CLASS F USD)

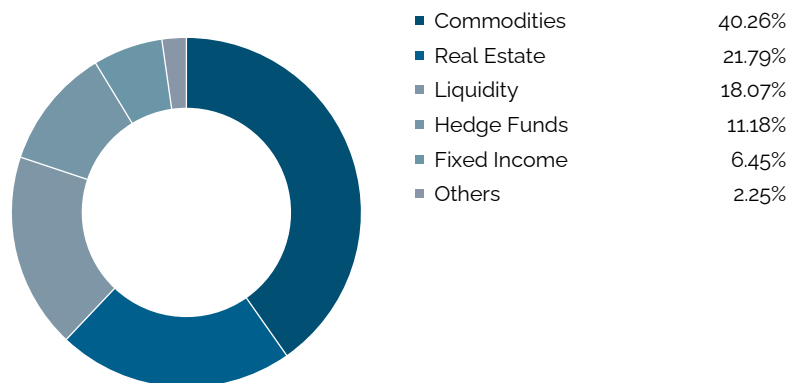

- The fund focuses on alternative investments in areas such as precious metals & commodities, liquid hedge funds and liquid products in real estate
- The focus is on direct investments as well as ETFs, ETNs, funds, REITs and structured products
- The Fund employs a typical top-down approach to the selection process, using multiple macroeconomic factors as well as external research to determine which Alternative Investment subthemes currently offer attractive future return opportunities
- Macroeconomic factors may include supply/demand, global monetary as well as fiscal policy, and geopolitics

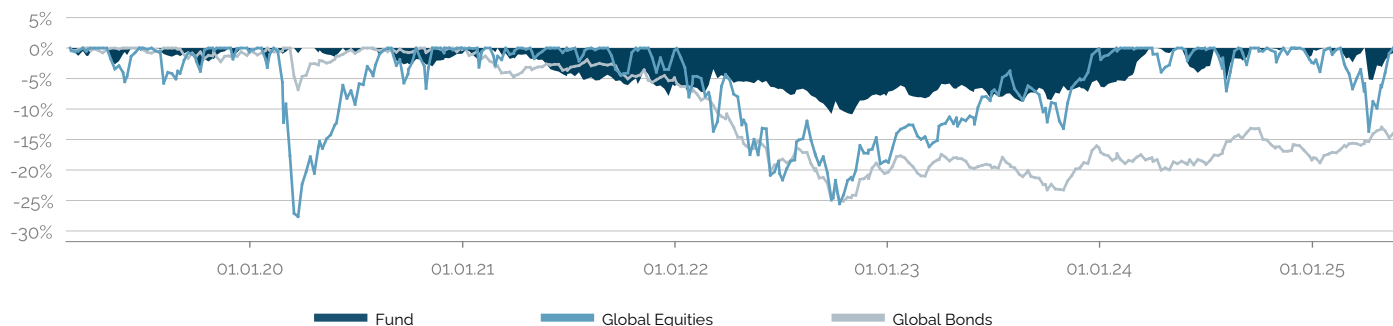
